ANNOUNCEMENT

THE STATE OF ALABAMA DEPARTMENT OF HUMAN RESOURCES (DHR) WILL RELEASE A REQUEST FOR PROPOSAL (RFPs) FOR ALABAMA EDUCATION ASSISTANCE PROGRAMS AND INDEPENDENT LIVING CONFERENCES AND CAMPS ON THURSDAY, MARCH 22, 2018.

The ALABAMA DEPARTMENT OF HUMAN RESOURCES, (hereinafter referred to as “the Department”) seeks qualified vendor to administer the **Alabama Educational Training Voucher Program (ETVP) and Fostering Hope Scholarship Program (FHS) through the Alabama Education Assistance Program** and to develop and coordinate **Independent Living Conferences and Camps**.

Under the *Alabama Educational Assistance Programs*, the **Alabama Educational Training Voucher Program (ETVP)** provides monetary assistance and educational vouchers to eligible youth who are enrolled in postsecondary accredited educational institutions. This program provides educational and training vouchers to eligible youth who are in or have aged out of foster care or who were adopted from foster care after turning 16 years old. *ETVP* allows the department to expand and supplement the current assistance provided to former and eligible foster care youth and specifically helps them begin, continue and/or complete their educational and vocational goals. **Fostering Hope Scholarship Program (FHS)** provides federal and state financial assistance to eligible youth who are enrolled in an accredited postsecondary institution of higher education.

The Independent Living Conferences and Camps consist of 1) two (2) three-day youth camps/conferences for foster youth; 2) an ILP Networking Conference for DHR staff and providers; and 3) provide support services for Alabama foster youth ages 16-21 and former foster youth ages 18-25. It also includes development and coordination of services with DREAM Council and support of the State Independent Living program. A more complete description of the services sought for these projects is provided in *Section 3, Scope of Project* of the RFP documents. Proposals submitted in response to this solicitation must comply with the instructions and procedures described in the procurement document.

The initial contract term for both projects is for a period of **three (3) years** beginning **October 01, 2018** and ending **September 30, 2021**. Renewals of the contract, as agreed upon by both parties, may be made at one year intervals, or any interval that is advantageous to the Department, not to exceed a total of **two (2) years**, at the option of the Department. ***Selected vendors must be fully operational on Monday, October 01, 2018.***
